1. I, the applicant signing below choose to have my child/ward _____(camper) to utilize the services, facilities, swimming pool and/or camp programs offered by the Ultimate Sports Camp, the SportDome, and BranHaven Swim and Tennis Club.

I hereby agree that the use of the services, facilities, swimming pool, and/or camp programs is at my child's/ward's own risk, and I assume, on behalf of my child/ward, all risk for injury or loss to which he/she may be exposed while on the premises of the SportDome and BranHaven Swim and Tennis Club. I am aware that camp and swimming pool activities are vigorous and potentially dangerous sporting activities that involve various risks, dangers and hazards and possibility of personal injury, death and loss of property. To a large extent, these risks, dangers and hazards derive from the challenging nature of the activities, the swimming pool environment, and the negligence of other participants.

In consideration of my child's/ward's use of such services, facilities, swimming pool, and/or camp programs, I on behalf of myself, my child/ward, our heirs and assigns, expressly agree to forever discharge, waive and release the Ultimate Sports Camp, the SportDome, KEM Investments, Inc., Kempthorn Motors, Inc, their partners, BranHaven Swim and Tennis Club, OGEN, LLC, their partners, sponsors, counselors, instructors, agents, employees and owners from any claims, responsibility or liability due to injury, damage or death arising out of or in connection with said camper's participation in camp activities and in the use of the Ultimate Sports Camp's services, facilities, swimming pool and/or camp programs and agree to hold the Ultimate Sports Camp, the SportDome, KEM Investments, Inc., Kempthorn Motors, Inc, their partners, BranHaven Swim and Tennis Club, OGEN, LLC, their partners, sponsors, counselors, instructors, agents, employees and owners harmless from any and all such claims.
